1. name and surname – in order to issue URBANCARD Wrocław City Card (in case of the first Card free of charge) including graphic personalization (card inscription) and electronic personalization (record in an appropriate card sector) and identification in case of any complaints as referred to in § 13, 14, 15 of General Terms and Conditions of entering into an agreement on transport by means of municipal public transport with use of URBANCARD – Wrocław City Card (hereinafter referred to as: GTCAT),
2. likeness (photo) – in order to issue URBANCARD Wrocław City Card (in case of the first Card free of charge) and to personalize a card graphically (card imprint),
3. PESEL personal identification number - in order to issue URBANCARD Wrocław City Card (in case of the first Card free of charge) and to identify a holder in case of any complaints as referred to in § 13, 14, 15 of GTCAT,
4. student, postgraduate student, pupil, veteran or victimized person status – in order to determine entitlements to discounts or travelling free of charge,
5. address, home or mobile phone number, e-mail – in order to inform about URBANCARD Wrocław City Card issue or any gaps or errors in an application for card issue and about other matters related to using URBANCARD Wrocław City Card, which are significant for a user,
6. card number - in order to issue URBANCARD Wrocław City Card (in case of the first Card free of charge) including graphic personalization (card inscription) and electronic personalization (record in an appropriate card sector).

You are authorized to have access to your personal data and to alter them.

Giving your personal data is voluntary, however:
